## GENERAL NOTES:

5. TIMBER FRAME HQ ASSUMES NO RESPONSIBILITY FOR ANY CHANGES OR MODIFICATIONS THAT MAY BE MADE TO THE PLANS BY THE OWNER OR THE OWNERS CONTRACTOR OR SUBCONTRACTOR.

6. THESE ARE "DESIGN ONLY" PLANS AND ARE NOT ENGINEERED PLANS. IT IS THE SOLE AND EXCLUSIVE RESPONSIBILITY OF THE OWNER AND THE OWNER'S CONTRACTOR OR SUBCONTRACTOR'S TO DETERMINE IF ENGINEERED PLANS ARE NECESSARY PURSUANT TO LOCAL OR STATE CODE REQUIREMENTS AND WHETHER STATE OR LOCAL BUILDING CODE REQUIREMENTS REQUIRE MODIFICATIONS OF MATERIALS OR STRUCTURAL SPECIFICATIONS ON THESE PLANS.
